Welcome New Delegates and Committee Volunteers

C. Covert-ByBee welcomed the new delegates and committee volunteers to the ASLP and thanked them for their service.

Executive Committee Report

- C. Covert-ByBee reported that the ASLP Compact, the Occupational Therapy Compact, and the Counseling Compact formed a tripartite partnership, known as the "Joint Compact Commissions Partnership" to provide joint funding for an essentially universal data system that could be used by all three. Each Compact agreed to provide up to \$500,000 dollars. (ASHA contributed the \$500,000 for the ASLP partnership share).
- I. Eliassen from CSG gave an update on the status of the data system. The contract has been signed and work on constructing the data system is underway. Inspiring apps is conducting bi-weekly sprint reviews with CSG and representatives from the Joint Compact Commissions Partnership to review progress.
- K. Buckholt from CSG reviewed the nomination and election process for electing a new Secretary for the Commission to replace Nicole Jeffcoate whose term has expired.

Rules Committee Report

G. Thornton gave an overview of the proposed bylaw changes cleaning up redundant language in the bylaws.

A. Bilodeau motion to adopt the proposed bylaw changes as written. T. Cranfill seconded the motion. Motion passed with 38 of 40 delegates voting to adopt the agenda.

Finance Committee Report

B. Fairfax reviewed the proposed FY25 ASLP-IC budget. D. Floyd highlighted budget items and reductions in certain line item expenditures.

C. Cid motion to adopt the proposed 2024-2025 budget, L. Hardcastle seconded motion. Motion passed with 29 of 40 delegates voted to adopt the proposed FY25 ASLP-IC Budget; 1 voted not to adopt (Ann Bilodeau, IN); 2 abstained

Proposed New Committees & Committee Appointments:

N. Kalfas, Legal Counsel reviewed the process of committee appointments. It is also important to note that all members of the Executive Committee are elected to a 2 year term, which will be expiring for the majority of the EC at the Annual meeting in September. EC members are eligible to be elected to a second 2 year term, as long as they remain delegates. Dr. Larry Molt, current Executive Committee Chair, will be rolling off as a delegate on October 1st, so we will need to elect a new Chair.
