### INTRODUCTION

On behalf of the Audiology and Speech-Language Pathology Compact Commission ("ASLP-ICC" or "the Commission"), we are pleased to present the second annual ASLP-ICC Report. This report spans the time frame from the second meeting of the Commission in 2023 through to the annual meeting in 2024. The 2023-2024 Report highlights the Commission's growth and activities, provides helpful information from Commission Meetings, details bylaws / rulemaking / policy development, and provides background on the process leading up to the formation and seating of the Commission in 2022. In addition, the Report includes a current Organizational Chart and Rosters of current Delegates and ASLP-ICC staff and counsel.

Launching the first interstate compact for audiology and speech-language pathology has been a complex, demanding, and challenging experience. Much of the work has been carried out by unpaid volunteer workers, the delegates to the Commission. The assistance and support of the Academy of Doctors of Audiology (ADA), American Academy of Audiology (AAA), American Speech-Language-Hearing Association (ASHA), Council of State Governments (CSG), and National Council of State Boards of Examiners for Speech-Language Pathology and Audiology (NCSB) has been invaluable. While many challenges still lie ahead, I am very proud of the work accomplished by the commission members and the affiliated associations and organizations, and I am very excited about the future.




### **ABOUT THE ASLP-IC**

The Audiology & Speech-Language Pathology Interstate Compact (ASLP-IC) facilitates the interstate practice of audiology and speech-language pathology while maintaining public protection. ASLP-IC provides a mechanism to allow for the legal, ethical, and regulated practice of interstate practice and telehealth by:

- granting qualified audiologists and speech-language pathologists the privilege to practice in ASLP-IC member states;
- allowing telehealth to be practiced in ASLP-IC member states;
- · allowing for increased access to underserved communities; and
- giving military personnel and spouses a means to maintain their profession when relocating.

### **ABOUT COMPACTS**

Interstate compacts are contracts between states, enacted via the legislative process, which establish formal agreements between states. Compacts have been recognized for years to be durable policy solutions. The most well-known compact is the Driver's License Compact, but many others have been used to address geographic, economic, regulatory, and administrative issues. Each state has enacted at least one compact, and most have enacted an average of twenty-five compacts.

Additionally, there has been continued growth in the number of interstate compacts for occupational licensure. The ASLP-ICC would like to thank CSG's National Center for Interstate Compacts for the following information.

Currently, there are multiple interstate compacts for occupational licensure in development, including:

- Athletic Trainer Licensure Compact
- Esthetician Licensure Compact
- Respiratory Care Interstate Compact (Respiratory Therapy)

Several other professions have prepared occupational interstate compact legislation that is ready to be introduced at the state-level, but have not reached the threshold for operation:

- The Interstate Compact for School Psychologists





### Occupational Licensure Compact Enactments by State






### Occupational Licensure Compact Enactments by Compact

# **ABOUT THE ASLP-ICC**

The Commission is the entity charged with administering the ASLP-IC. The Commission is a governmental and joint public agency comprised of the states which have enacted the ASLP-IC through a legislative effort and are, therefore, able to participate in the work of the Commission. The Commission is made up of two representatives from each ASLP-IC participating state, one who is an audiologist and one who is a speech-language pathologist. The Commission's Executive Board is comprised of seven members who are elected to serve as the leadership board of the Commission and three ex-officio members who represent the national audiology association, the national speech-language pathology association, and the national state licensing board association. The Commission engages in best practices with regard to open meetings and transparency in accordance with the Compact and Commission Bylaws.



### LEGISLATIVE UPDATES

ASHA has contracted with the CSG to assist in passing Compact legislation in the states. In the 2020 calendar year, a total of six jurisdictions passed ASLP-IC legislation: Louisiana, North Carolina, Oklahoma, Utah, West Virginia, and Wyoming. In 2021, nine jurisdictions passed the ASLP-IC legislation: Alabama, Colorado, Georgia, Kansas, Kentucky, Maryland, Nebraska, New Hampshire, and Ohio. In 2022, eight jurisdictions passed the ASLP-IC legislation: Delaware, Idaho, Indiana, Iowa, Mississippi, Missouri, South Carolina, and Tennessee. In 2023, seven jurisdictions passed the ASLP-IC: Arkansas, Maine, Montana, Vermont, Virginia, Washington and Wisconsin. Finally, in 2024 four jurisdictions have passed the ASLP-IC legislation: Alaska, Florida, Minnesota, and Rhode Island. In total to date, 34 jurisdictions have enacted the ASLP-IC. The Commission is grateful to ASHA and CSG for its continued work on this effort.

### FINANCIAL SUMMARY 2023-2024

The ASLP-IC is an agreement between member states designed to facilitate the interstate practice of audiology and speech-language pathology across state boundaries without having to become licensed in additional member states. Audiologists and speech-language pathologists licensed in their Home State, which is a member of the ASLP-IC, are able to practice into other member states via a privilege to practice issued through the Commission. The purpose of the ASLP-IC is to increase public access to needed audiology and speechlanguage pathology services by increasing access to care and providing mechanisms for continuity of care all while ensuring a higher degree of consumer protection across state lines. The ASLP-IC also promotes cooperation between member states in the areas of licensure and regulation. To join the ASLP-IC, a state must enact the model statute into law. The ASLP-IC is governed by the Commission, a governmental entity made up of the member states. The Commission meets annually. The Commission has approved a Memorandum of Understanding (MOU) with Academy of Doctors of Audiology (ADA), American Academy of Audiology (AAA) and American Speech-Language-Hearing Association (ASHA), which covers the initial funding for services needed by the Commission. The Commission also has a MOU with the NCSB to act as the Secretariat for the Commission.

### STATUS OF THE ASLP-IC

The ASLP-IC had its tenth (10) state enact legislation in July 2021, the critical demarcation in the model legislation that allowed moving forward in developing the Commission. The ASLP-IC now has 34 states that have enacted the legislation. The Commission has been formed and Bylaws and Rules have been approved. The Commission is not yet fully operational and privileges to practice are not being issued. Progress has been limited to a certain extent by the requirement of a step-by-step development of the operational framework of the Commission, such as solidifying funding, selection of a Secretariat, providing a communication system for delegates, development of Bylaws and Rules, etc., while using volunteer committees to carry these out these requirements. A key second factor impeding progress has been the relative unavailability of critical items necessary for the operation of the compact. One such example is the lack of a commercially available database system that will allow member states (who utilize a variety of different data systems) to easily and efficiently communicate applicant data and operational issues to the Commission, and conversely allow the Commission to easily and efficiently transmit critical information on practitioners and operational issues to the member states.

#### Revenue

The Commission is currently not receiving revenue through the Compact. The Commission has not yet determined the annual state assessment fee or the cost of the privilege to practice.

### **Expenditures**

The Commission has a MOU with ADA, AAA and ASHA to cover the initial funds necessary to operationalize the Commission. These funds are to be used to cover secretariat costs, staffing, including counsel, professional fees such as the contract with the CSG, Directors & Officers Insurance, travel costs for the Commission.

### Other Information

As part of the MOU between the Commission and ADA, AAA, and ASHA, the associations will continue to assume most of the operating expenses until the Compact is issuing privileges to practice. The Commission will be responsible for funding the database and software systems to implement the Compact.

# ASLP-ICC OUTREACH AND EDUCATIONAL ACTIVITIES


