#### Update on approval of authorize.net for data system credit card processing services

- B. Fairfax shared that a credit card processing vendor for the data system. Authorize.net was chosen as the vendor. They have a 1.5% transaction fee, which is the lowest available.
- N. Kalfas indicated that the Counseling Compact and the OT Compact have already approved authorize.net as their vendor. Inspiring Apps has familiarity with that app. The Executive Committee has already adopted authorize.net as the vendor.
- Motion: L. White-Minnis moved to ratify the Executive Committee vote to accept authorize.net
  as the credit card vendor. D. Brown seconded that motion. All Delegates voted in favor and the
  motion carried.

#### Discussion and Approval of Administrative Fee recommendation to Executive Committee

- B. Fairfax shared the recommendation of administrative fee for compact privilege to practice as \$50.
- D. Brown asked about the differing renewal cycles for states. C. Covert-ByBee shared that the privilege is based on the renewal cycle for the home state license. The majority of states renew every 2 years, although some renew annually or triennially.
- **Motion**: L. White-Minnis moved that the administrative fee recommendation of \$50 be sent to the Executive Committee. D. Brown seconded that motion. All Delegates voted in favor and the motion carried.
