Review and Adoption of Minutes*

- C. Covert-ByBee reviewed the minutes and asked for a motion to adopt the March 23, 2026, Executive Committee meeting minutes.

Discuss and Adopt Rules on Dispute Resolution, Joint Investigations, Postgraduate Professional Experience, National Exam and Military Identification*

- G. Thornton indicated there are five rules that have been forwarded from the Rules Committee. These rules have been reviewed by N. Kalfas as well.
- G. Thornton reviewed the rule on dispute resolution and asked for a motion to adopt the rule.
- **Motion:** V. Pullins moved to adopt the rule on dispute resolution and send it to public comment. L. Snyder seconded the motion. All Delegates voted in favor and the motion carried.

- G. Thornton reviewed the rule on post graduate professional experience and asked for a motion to adopt the rule. N. Kalfas shared background information on the need to define this term.
- L. Snyder asked if this aligned with the clinical fellowship experience. S. Adams indicated that it aligned with most state licensing requirements.

Discuss and Adopt FY27 Budget*
