Discuss and Adopt Bylaw Amendment*

- G. Thornton reviewed the draft bylaw amendment, which includes staggered terms for members of the Executive Committee.
- **Motion:** V. Pullins moved to adopt the bylaw amendment and send to public comment, with clarification of lines 28-31. F. Wang seconded the motion. All Delegates voted in favor and the motion carried.

Update on CompactConnect

- N. Kalfas shared that Tennessee has planned to go live on May 28. Florida, Missouri, Colorado are expected within the next couple of months. Mississippi and Nebraska are close. South Carolina has security requests that are being worked through.
- C. Covert-ByBee shared that the build out of CompactConnect is essentially complete and continued funding is being used to onboard states. The Joint Compact Commission and the Counseling Compact are developing information, including FAQs and videos. CompactConnect is being offered to additional compacts as a data system. The Cosmetology, Dentistry and Social Work Compacts are actively working on connecting with CompactConnect with additional compacts finalizing their decisions.
- C. Covert-ByBee shared that funding requests have been sent to AAA and ADA. ASHA is currently working through its funding request.
